1. If the cargo is considered, in the reasonable opinion of the Operator, to be hazardous/dangerous, then an additional 20% surcharge will be applied.
2. If the cargo handled is non-containerized, applicable charges will be based on dry containers.
3. Any additional movement of a container, flatbed, or trailer within the boundaries of the Riyadh Dry Port Ecosystem upon the request of the shipping line/broker/consignee/shipper or agent or any other parties shall be charged SR 64 per movement/unit.
4. The fee of a worker is SR 11 per hour or part thereof, the fee of a skilled worker or technician is SR 22 per hour or part thereof, the fee of an engineer or supervisor is SR 32 per hour or part thereof, if applicable.
5. Overweight container Limitations 20'FT (25 tons) and 40'FT (or longer) (30.5 tons)

1. Import round trip movement – Journey of Import Container from King Abdulaziz Port in Dammam to RDP and returning Container to DEC Yard.
2. To be eligible for discounted rate, Shipping line should complete the laden import and export cycle with same container within 60 days from the date of arrival in RDP.
3. Out of Gauge Loads ("OOG") – All OOG loads must not exceed the following dimensions and must be subject to a SAR rail loads safety exam prior to acceptance to trains:
 - OOG load must not exceed 11,776 mm in length
 - OOG load must not exceed 2,228 mm in width
 - Exterior of load must not exceed 5,600 mm in height from ground
 - Maximum Gross Weight must not exceed of OOG load and container must not exceed 34,000 kg
